

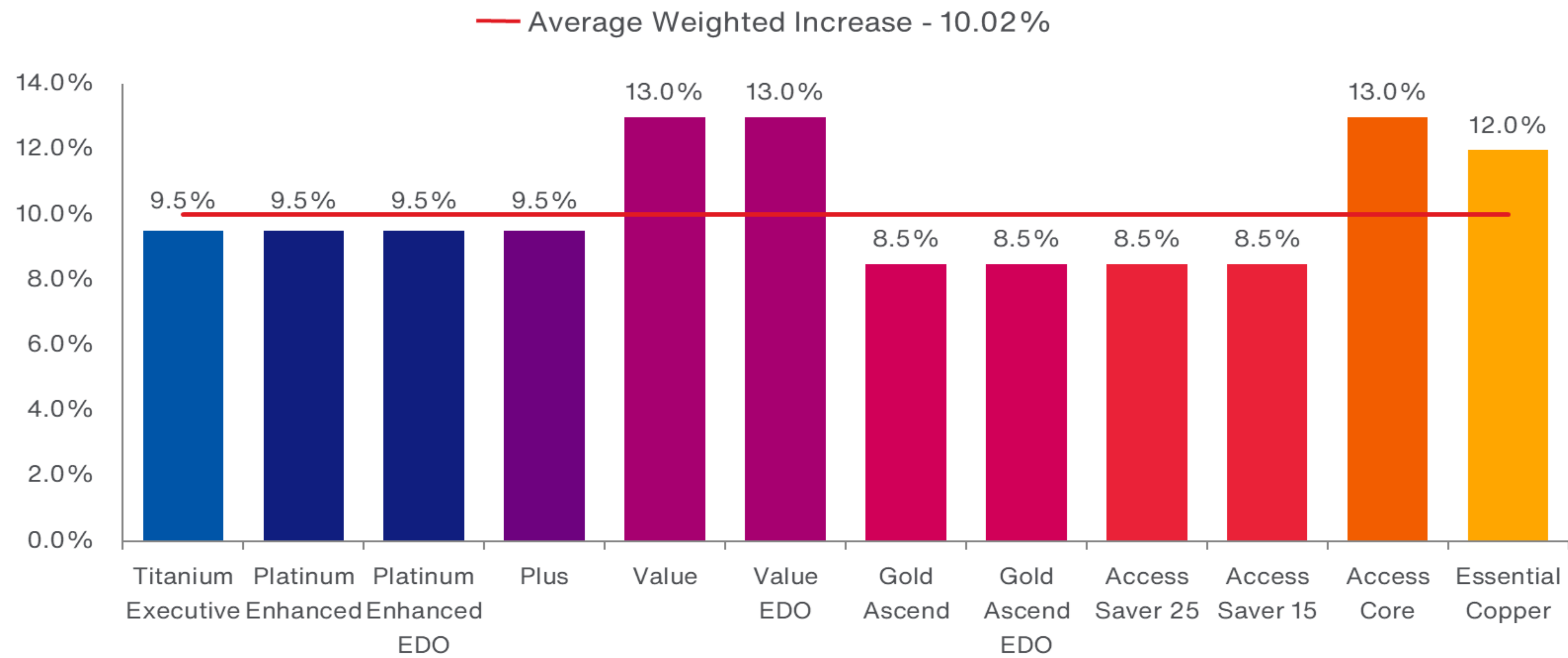

2024 Benefit changes



Sizwe Hosmed announced a 10.02% **Average Weighted Increase** with effect 1 January 2024

2024 Benefit changes

Key Benefit changes:

The Hospital Saver option renamed Access Core from 1 January 2024, all other options structure will remain the same

Benefit Enhancements:

The Scheme has announced the following benefit enhancements for 2024 across all options:

- Co-payments removed for procedures done at day facilities.
- Introduction of a sub-limit for physiotherapy and occupational therapy specifically for consultations during psychiatry admissions.
 - Sub-limit of R2,000 for physiotherapy
 - Sub-limit of R1,400 for occupational therapy
- Increase to 10 ante-natal consultations at a GP, specialist or midwife of choice, subject to maternity programme registration.

Wellness and Preventative benefits

- All screening and preventative benefits to be paid at 100% scheme rate across all options from the risk benefit.

2024 Benefit changes

Benefit Enhancements continued:

- Immunisation protocol to change from 12 months to 12 years as per Department Of Health guidelines.
- Additional eyes, ears and heart screening for children under the age of 2 years.
- For females over the age of 50 paired mammogram with bone density studies.
- Audiology screening available to all beneficiaries over age 65 once every 2 years.
- All beneficiaries over 55 years access to screening for Lung Cancer and Skin Cancer.
- In addition to the available Eye Screening for Diabetics, the introduction of Diabetic Foot Screening.

Benefit changes

- Introduction of dental screening and wellness mobile unit.
- Introduction of the voice of the member survey that must be completed by the member after hospitalisation, in order to determine quality of care.

2024 Benefit Changes

Benefit reduction:

- A 20% co-payment will apply for voluntary use of a non-day hospital facilities, this will exclude PMB conditions, psychiatry admissions
- Maternity benefit - Antenatal vitamins to be capped at R270 for the pregnancy cycle.

Benefit limit increases:

Day-to-day and in-hospital benefit limits will increase by 5%.

Loyalty Programme

- Introduction of Just Rewards Wellness Programme launching soon.
- Existing Sizwe Hosmed members will have access to enroll on the programme 1 January 2024 at a monthly fee of R149.
- New Sizwe Hosmed members enrolling on 1 January 2024 will enjoy complimentary 3 months access at no cost.
