


Aon Member Letter 2024 Medihelp Medical Scheme

Dear Aon Client,

It is that time of the year for you to evaluate your current healthcare arrangements to ensure the most appropriate cover for 2024. Whether you wish to remain on your current option or change to a more suitable option for 2024, it remains Aon's responsibility to guide you through the review process. This will ensure that you make an informed decision regarding your healthcare cover for 2024.

What is the contribution increase for 2024?

Medihelp Medical Scheme has announced a weighted average contribution increase of 15.97% effective 1 January 2024.

New Benefits

MedVital PMB benefit

In 2024, the Prescribed Minimum Benefits (**PMB**) rule will be applied for certain procedures on **MedVital**. These procedures include Facet Joint Injections, Functional Nasal Repair, Umbilical Hernia Repair, Incisional and Hiatus Hernia repair as well as Varicose Vein Surgery.

DNA Analysis

Medihelp will be using drug-gene testing or pharmacogenomics for high-risk patients in managing their medication (protocols will apply). In these cases, the test will be funded from the core benefit. Any member on the **MedSaver** option can choose to do the test and will it be funded from their savings account. The benefit is not available on the MedMove option.

CoCare Centres of Excellence

Partnering with quality hospitals and medical professionals, Medihelp will in the future offer a number of care baskets for specific procedures. These CoCare Centres of Excellence will consist of a carefully selected interdisciplinary team of medical professionals and will be rolled out in 2024. When members apply for pre-authorisation for procedures such as cataract surgery, they can consider this care basket alternative to cut down on potential out-of-pocket expenses.



Benefit enhancements

Benefits across most options increased by on average 5%.

Disease Management programme

Medihelp will be offering a Disease Management Programme to assist members living with high cholesterol, diabetes, and high blood pressure. The Disease Management programme will be integrated with the Member Zone to assist members in complying with treatment and the risks associated with these diseases.

Treatment of major depression

Another benefit package on offer will be for the treatment of major depression out of hospital instead of hospitalisation. This will be available in consultation with the treating psychiatrist on a case-by-case basis.

Back and Neck treatment programme

Members are currently required to participate in the Documentation Based Care (DBC) treatment programme or an alternative treatment as a prerequisite for spinal surgery. In 2024, if the DBC treatment programme or alternative treatment is followed, and surgery is clinically justified and authorised, members will not be liable for any co-payments.

If alternative treatment was not considered and if surgery is not clinically justified, a co-payment will apply. The table below sets out the co-payments that will apply in 2024 in these instances:
