- The overall annual limit for 2024 has increased from R185 837 to R198 600 per insured per annum.
- The Tariff Shortfall benefit has increased from 500% to 600% of medical scheme rate.

New Benefit for 2024

- A lump sum benefit for the first-time diagnosis of cancer to the medical equivalent of stage 2 or higher form of cancer. The benefit is only payable during an Insured event. It excludes any form of cancer that was previously identified or required treatment prior to 2024.
- The benefit is subject to one claim per Insured Party for the lifetime of the Policy limited to R15 000.
