

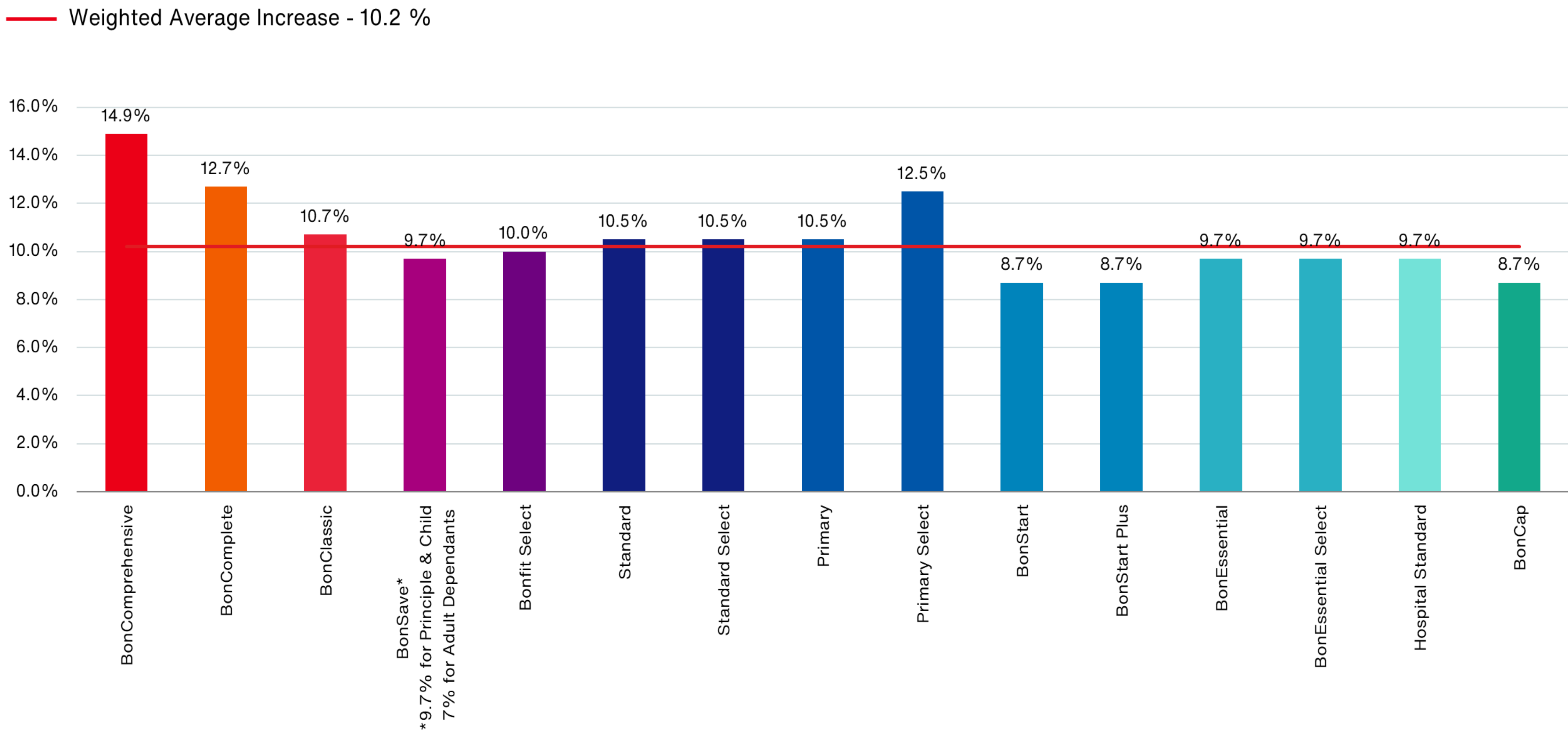

2025 Benefit Changes

Key Benefit Enhancements:

- **Mother and Child Care Benefit, including Maternity Program:**
 - 2 vision screenings tests by a qualified ophthalmologists for premature newborns on all options except BonCap.
 - Milestone reminders for children under three
 - Immunisation reminders and
 - Online screenings for infant and toddler health
 - Maternity Program – greater support for expectant mothers with high-risk pregnancies and support on mental health pre and post natal
 - Antenatal vitamins will be covered from acute benefits or Benefit Booster on certain options subject to brand value and formulary
- **Diabetes: The introduction of Diabetes Nurse Educators**
 - Offered to members with Diabetes by providing 2 consultations with a Diabetic Nurse Educator on all options except BonCap
- **Realigned PET scan benefit**
 - Introduction of PET scan network
 - Number of PET scans are option dependant

2025 Benefit Changes

Key Benefit Enhancements continued:

- **Extended Mental Health Support**
 - To include Pre and Post Natal Maternity depression
- **Audiology Benefit Management Program renamed Hearing Loss Management Program**
- **Dental Benefits**
 - Dental fissure sealants will be available on all plans including Hospital Select
- **Blood pressure monitor**
 - Introduction of a benefit up to R1200 per family over a 2-year cycle on certain options
- **Chronic medicine management**
 - Reduction of the co-payment for the use of non-DSP or non-formulary medicine on all options reduced to 30%
 - Broaden access to chronic medicine on certain options to include Bonitas Pharmacy Network

2025 New Care Programs

- **Female Health Program**
 - In collaboration with CareWorks for all females 18 and above with the emphasis on preventative care and early detection of female specific health issues based on life stage
- **Weight Management Program**
 - Designed to reduce risk associated with non-communicable diseases by improving clinical risk indicators like waist circumference and body fat percentage
 - Available on certain options
- **Geriatric Care Program**
 - Personalised for senior over the age of 70 and offers a range of screening, prevention and wellness benefits in the comfort of their own home covered from risk
