2024 Benefit Enhancements

Overall Average Increase: 6.71% Transnet 0%

Rate for 2024: Remains R253 per family.

2024 Benefit Enhancements:

- On Sanlam Gap Comprehensive plan the tariff benefit increases from 500% to 600%.
- The overall annual limit increases to R198 660 per insured per annum.
- Benefit limits to increase by 6% for 2024 subject to policy limit:
 - Sub-Limit benefit increased to R64 500 per event.
 - Accidental Casualty benefit increased to R18 450 per event.
 - Casualty Child Illness benefit for children under age 12 increased to R2 860 per event.

- The benefit will only be available after 1 January 2024, following first time diagnosis and subject to specific criteria.

- Only available to Fedhealth Savvy and Elect members and cover includes:
 - Penalty co-payment benefit.
 - MRI & CT scan co-payment.
 - Casualty Ward co-payment as a result of an accident.
 - Sports Injury accidental casualty benefit.
