

2025 Benefits Changes

Benefit Enhancements:

- Introduction of the New Connect Network on the Ingwe Option. •
- A rand value for dental benefits has been introduced on the Health Platform. \bullet

Benefit limit increases:

- Benefits, co-payments and threshold levels will be increased in line with inflation. \bullet
- Income bands on the Ingwe Option will increase. \bullet

HealthSaver

- Members can earn up to R750 on Multiply Engage or Multiply Inspire and a further R250 on Multiply Engage Plus or Multiply \bullet Inspire Plus.
- Momentum HealthSaver will no longer limit transactional cards to two per contract. \bullet
- In addition, members who do not have a valid South African ID document, can now apply for a HealthSaver Card using their \bullet passport.
- When members apply for a new Momentum HealthSaver with credit, the amount of credit advanced upfront will be pro-rated, • based on the number of months remaining in the year.
