2024 Contribution and Benefit Changes

Contribution Increase

Flexicare Plus and Flexicare will have an average annual contribution increase of 8.5% effective 1 January 2024.

Flexicare Plus employer group policies will have a contribution increase based on group size and the claims utilisation.

Premium increases are based on factors such as:

- Provider tariff increases – trends in claims utilisation; and
- Adjustments in capitation arrangements with the Flexicare network of providers.

Benefit Enhancements

- Unlimited nurse consultations with GP referral.
