

2024 Benefit changes

New Benefit:

- **Intelligence Genetic Testing**
 - Test kit paid from available savings at a discounted rate ranging from R575 to R2 400 depending on which report you require.

Enhanced Benefits:

- **Preventative Care**
 - HPV **vaccine** criteria changed to cover girls aged 9 to 16 years of age
 - HPV PCR **test** to cover women aged 21 to 65 of age, every 5 years
 - Mammogram criteria changed to all lives aged 40 and older
- **Co-payments**
 - Co-payments for certain procedures have been removed

2024 Benefit changes

Limit Changes:

- **Co-payments**
 - All options have co-payment increases

Key Benefit changes:

- **Flexible Savings**
 - The Flexible Savings has been reduced to a maximum of 25% of total risk premium

Value Added Benefits:

- **Medway BiologiCare Programme**
 - Covers contribution increases due to upgrading your medical scheme option upon a cancer diagnosis
 - Extends cover for cancer treatment not covered by the medical scheme
 - Cost - R209 per family per month

 - Available to compliment the FlexiFed Elect and FlexiFed Savvy options
 - Covers Penalty, MRI, CT scans, Casualty ward co-payments and Sports Injury and Accident related casualty visits
