2024 Benefits Changes

Benefit Enhancements:

- Removal of pre-notification of Health Platform benefits on specific screening tests.
- Enhancements to the pap smear benefit as well as the introduction of HPV screening.

- Increase to income bands on the Ingwe Option.

- Introduction of a low-income option, called Fusion, subject to approval by the Council for Medical Schemes (CMS), available to employer groups.
