2024 Benefits Changes

Increase for 2024

- Individuals 6.7%
- Groups 7.9%
- Overall average increase for 2024 is 7.3%
- Pays 3x medical scheme tariff, the members' option choice will determine the amount paid out

2024 Benefits Changes continued

Benefit Enhancements:

- Shortfall limit has been increased from R185 000 to R190 000 per insured person, per year
- Allied Professional Shortfalls (Supreme Gap) has increased from R2500 to R3000 per policy per year
- Casualty benefit enhancement (Supreme Gap) limit of R22000 increased to R23000
- Emergency only benefit for children from 5-6years has been increased from R3500 – R4000 and is available at any time of the day. Age limit has increased to 7 years of age
- Non-DSP co payment limit increased from R5 500 to R10 000 - up to two events per policy per year and percentage based co payments will be covered.
- Sub limit benefit will increase from R12000 to R14000 per policy per year
- Cancer Assist benefit (Supreme Gap) has increased form R5000 to R8000 on a first-time cancer diagnosis
- Baby Bump has increased from R2000 to R2500 on confirmation of pregnancy
